BIDDING FOR THE APPOINTMENT OF A CONSULTANT FOR ADVISORY SERVICES FOR GOODS AND SERVICES TAX



Thousand only) including all taxes to be submitted before or at the opening of Technical Bids, in the form of crossed Demand Draft issued by any Scheduled Bank drawn in favour of "Commissioner, Commercial Tax Department, Uttarakhand" and payable at Dehradun.

3. Earnest Money Deposit (EMD) of **Rs. 1,00,000 (Rs. One Lakh Only)** by Demand Draft, pledged in favour of **Commissioner Tax Uttarakhand** and payable at Dehradun, which will be refunded, if the offer is not accepted. It is to be submitted before or at the opening of Technical Bids. In case, the offer is accepted, but not honored by the bidder, the Earnest Money will be forfeited.
2. Bids must be submitted online at www.uktenders.gov.in. The bidder has also to submit a hard copy of original copies of EMD, Bid document fees, Authorization Letter and other relevant desired documents on or before the time specified; otherwise bid will not be considered for the further process.
4. Bids will be opened in presence of Bidders' representatives who choose to attend on the specified date and time.
